Ladies and Gentlemen:

On March 16, 2006, the Vermont Public Service Board ("Board" or "PSB") issued an Order and Certificate of Public Good ("CPG") approving the Lamoille County 115 kV Project (the "Project") as proposed by Vermont Electric Power Company, Inc. (now jointly with Vermont Transco, LLC and referred to as "VT Transco"), Green Mountain Power Corporation and the Town of Stowe Electric Department (the "Petitioners"). Page 73 of the Order requires the Petitioners to provide design plans to the "affected parties" one month prior to filing the final design plans with the Board. The attached set of design plans for the Project relates to the proposed construction at VT Transco's Stowe substation in Stowe, Vermont.


